Application for Provisional Registration Certificate

When can you apply?

You can apply for a Provisional Registration Certificate with the West Bengal Medical Council after completing your medical education (MBBS). This certificate allows you to do the internship for 1 year.

How to Apply?

Step 1: Update Contact Information

- Navigate to the WBMC website and click on "Update Contact" or "Check Status".
 Direct URL- https://wbmc.wb.gov.in/index.php/update_contact/
- Select "Provisional Applicant".
- Enter your "Provisional Registration Number" and the "Year of Provisional Registration", then click on "SUBMIT".
- Your provisional registration details will be displayed. Proceed to update your contact details by entering your preferred information.
- Click on "NEXT" after entering your preferred contact details.
- You will receive OTP on your mobile number and Email. Enter the OTP and click on "SUBMIT".

[Your updated contact information will be sent for verification to WBMC. Wait for verification before proceeding to the next step.]

Step 2: Online Application

- Click on "ONLINE APPLICATION".
 - Direct URL- https://wbmc.wb.gov.in/index.php/online application/
- Login using your Registered Mobile Number.
- Enter the SMS OTP and CAPTCHA to proceed with the login.
- Click on "New Application" to start a new application process.
- Select the type of application you are applying for.
- Fill out the application form accurately and completely.
- Upload all the required documents as mentioned in the application form.
- Make the payment online to successfully submit the application.

Note:

If you have already updated your contact details at WBMC, you can directly login to apply for the Final Registration Certificate.

- ✓ Fill up the application form.
- ✓ Upload required documents.
- ✓ Pay online.
- ✓ Final submission

Why is a form not visible to me?

There are situations where a form may not be visible:

- ✓ If you're already registered with WBMC but logging to the web portal for the first time, it's mandatory to update your contact details (Mobile No. & Email ID) to access online applications.
- ✓ If your current registration status is Suspended.
- ✓ If you've already applied and the status is Pending.

How to validate digital signature in pdf certificate?

Below are some simple steps to follow to validate a digital signature:

- Open the PDF certificate in Adobe Acrobat
- Right Click on signature portion and select 'Validate'
 Signature'.
- Signature Properties
- Show Signature's Certificate
- Trust Tab
- Add to Trusted Certificates
- OK
- Certified Documents Tick
- OK

Reopen the PDF certificate to get the effect.
