Sir,

In terms of the provisions contained in the Bengal Medical Act, 1914 (as amended), this Council has issued Charge-sheet to you vide No. 4499 - C / 38 - 2021 of  $26\_03\_2025$  in connection with the complaint lodged by Sri Goutam Ghosh concerning treatment of his mother, Smt. Jharna Ghosh and her resultant death, which had duly been replied by you vide your letter dated  $16\_04\_2025$ . The same was taken into consideration by the Council through the President, WBMC.

The Council considered the case in their Extra-ordinary Meeting held on  $04\_07\_2025$  and initiated the proceedings in terms of the provisions of Section 16 of Rules under Clause (d)(I) of Sub Section(2) of Section 33 of the Bengal Medical Act, 1914 (as amended) since the complainant was not present. You were invited to state your case, which you did. You had also replied to questions put forward by the Members of the Council through the Chairman of the meeting.

On completion of the hearing, the Chairman called upon the Members present to vote on the question whether Dr. Rajendra Kumar Kachroo, Registration No. 43695 of WBMC was guilty of infamous conduct in a professional respect. The Council unanimously decided that the charges brought against Dr. Rajendra Kumar Kachroo, Registration No. 43695 of WBMC have been substantiated. In so far as the quantum of punishment, the Council unanimously decided the name of Dr. Rajendra Kumar Kachroo, Registration No. 43695 of WBMC from the register of registered medical practitioner for a period of 3 months from the date of communication of order in this respect under Section 25(a) (ii) of the Bengal Medical Act, 1914.

You are hereby advised to submit your Original Final Registration Certificate immediately from the receipt of this letter.

Your attention is being drawn to the provision under Section 26 of the Bengal Medical act, 1914 which reads as under:

Section 26 of the Bengal Medical Act, 1914:

Appeal to the Local Government from decision of Council:

26 (1): An Appeal shall lie to the Local Government from every decision of the Council under section 17 or section 25.

26 (2): Every appeal under the Sub section (1) shall be preferred within 3 months from the date of such decision.
